STRATEGY OVERVIEW AND OBJECTIVE

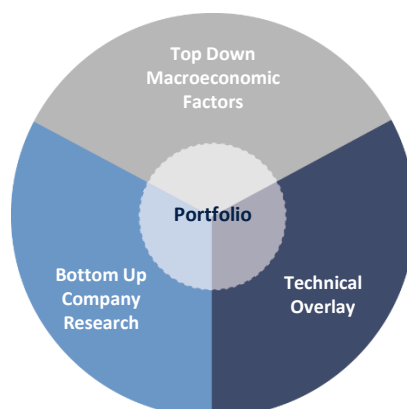
- Style-consistent large cap growth strategy

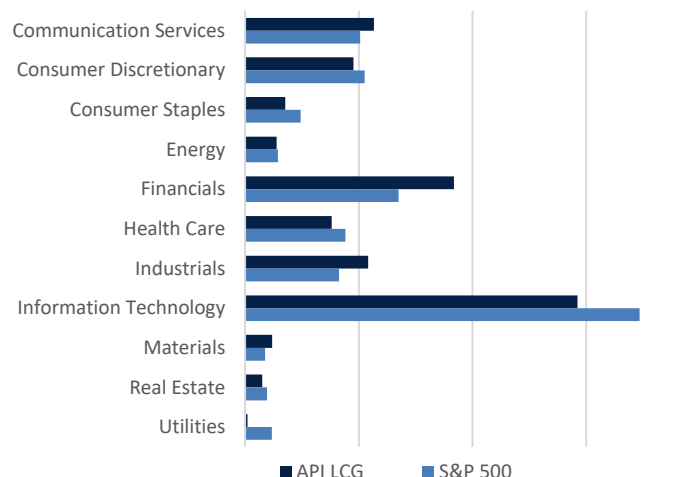
